FIRST AID STATUS

All instructors are first aid trained to an acceptable standard and sufficient emergency first aid equipment is always present at all classes and on site. A risk assessment and associated health and safety briefs are conducted prior to classes commencing.

HKC is associated with a professional association to ensure our standards are some of the highest available, however we remain legally independent and are not submitted to any compulsory regulation or obligation under any of the above named associations.
